Background

In June, 2021, Presidio County received an award for a TXDOT Coronavirus Relief Airport Grant. The grant award is \$9,000. The purpose of this grant is to prevent, prepare for, and respond to coronavirus. Funds can be used to reimburse airport costs related to airport operations and activities as a result of the COVID-19 pandemic. Requests for reimbursement of costs incurred between 1/20/2020 and 6/26/2025 can be submitted against this grant. Since this is an un-budgeted item, a budget amendment is required.

I have reviewed the grant information and certify the availability of this unanticipated revenue.
