COVID-19 VACCINE ROLL OUT INFO FOR JEFF DAVIS AND
PRESIDIO COUNTY ON FEB 8TH AND FEB 9TH**

Fort Davis

On Monday, February 8, 400 doses of Covid-19 vaccine will be administered in Jeff Davis County by a team from Midland Memorial Hospital. Vaccination will take place at the **Jeff Davis County Fire Station** and will be conducted similarly to our periodic testing. Everyone will enter the fire station parking lot from Woodward Avenue, then park and walk into the fire station to receive vaccine. Volunteers will be present to assist.

Vaccination will begin at 10:00 am and end at 4:00 pm. Due to the short notice of vaccine availability, there is not enough time to make appointments in advance. Therefore, vaccination will be on a first come, first served basis. Even if you have preregistered, you will not be contacted; just show up at the fire station on Monday, February 8.

Registration forms will be available online on the Jeff Davis County website or can be picked up at the County Judge's Office in advance. If you need additional information, please call Judge Evans' office at 432-426-3968. **Registration is open to tri-county residents.**

Marfa

On Tuesday, February 9, 400 doses of Covid-19 vaccine will be administered in Presidio County by a team from Midland Memorial Hospital. Vaccination will take place at the **Marfa Visitors Center (USO)**. Everyone will enter the Visitors Center through the main doors on Highland Avenue and proceed to the ballroom to receive vaccine. Volunteers will be present to assist.

Vaccination will begin at 10:00 am and end at 4:00 pm. **Appointments are necessary for Marfa Vaccination Clinic. You must call Marfa Country Clinic at 729-3000 to make an appointment in order to be vaccinated. Registration is open to tri-county residents.**

Registration forms will be available online on the Presidio County website or can be picked up at the County Judge's Office in advance. If you need additional information, please call Judge Guevara's office at 432-729-4452. **Registration is open to tri-county residents.**

Vaccination is open to anyone in the Phase 1A category (health care workers and first responders) or the Phase 1B category (people 65 years of age or older, and people 16 years of age and older with at least one chronic medical condition that puts them at increased risk for severe illness from the virus that causes COVID-19). You must qualify as 1A or 1B to receive vaccine at this time.

Vaccination will be done using the Pfizer-BioNTech vaccine. This is a two-dose vaccine. Persons receiving their first dose on Monday, February 8, will receive their second dose on Monday, March 1, at the Jeff Davis County Fire Station.

Persons receiving their first dose on Tuesday, February 9, will receive their second dose on Monday, March 2, at the Marfa Visitor's Center. Please note that this is for first doses only. If you need a second dose, please contact the provider who gave you the first dose.
