The no-new-revenue tax rate is the tax rate for the <u>2021</u> tax year that will raise the same amount of property tax revenue for <u>PRESIDIO</u> <u>COUNTY</u> from the same properties in both the <u>2020</u> tax year and the <u>2021</u> tax year.

The voter-approval rate is the highest tax rate that <u>PRESIDIO COUNTY</u> may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that <u>PRESIDIO COUNTY</u> is proposing to increase property taxes for the <u>2021</u> tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON <u>THURSDAY</u>, <u>SEPTEMBER 16</u>, 2021, 10:00 A.M. at the <u>PRESIDIO COUNTY COURTHOUSE</u>, 300 N. <u>HIGHLAND</u>, IN <u>THE COUNTY JUDGE'S OFFICE</u>, <u>MARFA</u>, <u>TX 79843</u>. The proposed tax rate is not greater than the voter-approval tax rate. As a result, <u>PRESIDIO COUNTY</u> is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the <u>COMMISSIONERS COURT</u> of <u>PRESIDIO COUNTY</u> at their offices or by attending the public hearing mentioned above.
