Drilling Permit Term: This Drilling Permit is effective for 120 (one hundred twenty) calendar days after the date the District issues the permit. If each well is not drilled or if each existing well is not properly completed to meet all statutory and regulatory requirements for the intended purpose of use within the 120-day drilling period, the Drilling Permit expires. The General Manager may extend the Drilling Permit term beyond 120 days, if requested and good cause is shown.

Operating Permit: Immediately upon completion of a new water well, or reworking or re-equipping an existing water well, a completed Operating Permit Application must be filed with the District. An Operating Permit will not be renewed unless the well has been drilled at the time of renewal.

Declaration: I agree that reasonable diligence will be used to protect groundwater quality. I agree that the water withdrawn from the drilled well will be put to beneficial, non-wasteful use at all times. I agree to comply with the rules of the District, all groundwater use permit terms and conditions and plans promulgated pursuant to the District's Rules, Management Plan, and orders of the District's Board of Directors. I agree to comply with the District's well capping and plugging guidelines and to report any well closure to the Texas Commission on Environmental Quality. Furthermore, I agree not to produce groundwater from this well without a valid Operating Permit.
