#### **Background**

The Commissioners Court has exempted from formal bidding the retro-fit of the Jail control system. The quoted cost of this retro-fit is \$61,430. The funds to cover this project are available in the Jail reserves.

Section 111.010 of the Local Government Code requires commissioners court to spend county funds only in strict compliance with the budget except as follows:

The commissioners court may authorize an emergency expenditure as an amendment to the original budget only in a case of grave public necessity to meet an unusual and unforeseen condition that could not have been included in the original budget.

If the court chooses to approve the budget amendment requested above, the following motion should be used:
