Current Situation: At least 119 new coronavirus deaths and 6,407 new cases were reported in Texas on Feb. 21. Over the past week, there has been an average of 4,482 cases per day, a decrease of 67 percent from the average two weeks earlier. As of Monday afternoon, there have been at least 2,602,405 cases and 42,390 deaths in Texas since the beginning of the pandemic, according to a New York Times database.

The Texas Department of State Health Services (DSHS) is currently reporting a total of 2,241,808 cases of COVID-19 in the State of Texas which includes an estimated 211,343 active cases. 2,312,445 individuals have recovered from the

virus and 41,213 confirmed COVID-19 related fatalities. Across Texas, a total of 19,127,832 COVID-19 molecular tests have been completed. DSHS is also reporting, Texas has received and distributed a total of 6,001,125 doses of COVID-19 vaccine, which has been administered to 4,395,705 people in 254 Texas Counties.
