Case #24 is hospitalized. Cases #19, 20, 21, 22, 23 and 25 are currently isolated. DSHS and Local Health Authority JP Schwartz, D.O., are supporting Presidio County in identifying any close contacts so they can be isolated and monitored for symptoms.

If the health department or the Local Health Authority has not contacted you, there is no need to take any action at this time.

- If soap and water are not available, use a 60% alcohol-based handsanitizer.
- Avoid touching your eyes, nose, and mouth with unwashed hands.
- Avoid close contact with people who are sick.
- Stay home when you are sick.
- Cover your cough or sneeze with a tissue, then throw the tissue in the trash.
- Clean and disinfect frequently touched objects and surfaces.
